I agree that I will not file suit on behalf of my child/ward or myself against TBCN and/or its officers, directors, employees and other agents, until I have submitted any claim, dispute or complaint for resolution pursuant to the Complaint/Grievance Procedures and Appeal processes set forth in the TBCN Policy & Procedures manual and such procedures and processes have been finally and completely concluded. Following conclusion of such TBCN P&P procedures or proceedings, in any further dispute, mediation, arbitration, litigation and/or appeal, including without limitation interpretation or enforcement of this agreement and any claim of intentional tort, breach of duty or contract or violation of my rights or those of my child/ward by TBCN, that arises from any aspect of her/his relationship with TBCN, the prevailing party or parties shall recover its/their costs, including reasonable attorneys' fees, from the other party or parties.

This agreement expresses the entire understanding and agreement of each party and cannot be modified, waived or discharged except by written instrument or instruments executed by each of the parties thereto. It shall be governed, construed and performed according to the laws of the State of Florida.

The parent or legal guardian must signify that they agree to the terms stated above by signing this agreement, IN PERSON, at 1001 W. North B Street, Tampa, FL in the presence of an authorized associate of Tampa Bay Community Network.
